UPDATES FOR 2024

This year we are making two significant changes to expand competition access and benefits to potential applicants:

- The competition is now open to entrants residing anywhere within the United States.
- In the weeks following notification of competition winners, we will be offering all applicants (regardless of winner/non-winner status) the opportunity to participate in a **virtual Q&A symposium**, moderated by PMSF Board members, during which the judge(s) of their entry category will answer general questions pertaining to their musical development, studies, and careers. Dates, format, and other logistics will be determined and disseminated in the coming months.

Otherwise, the competition format follows last year's, with a single round of judging based on electronic submissions (video submissions for the performance categories), contestants receiving individualized feedback from the judging panel, and winning submissions featured in an online showcase. Winners will be announced on or around March 4, 2024.

We would also like to reiterate our recently-initiated capital campaign to help sustain the Pacific Musical competition for the next century. ELIGIBILITY

Applicants must currently reside in the United States, including all states and territories. Past First Place winners in may not compete in the same age group and category; they may compete in another age group when they are age appropriate. Past First Place winners in the Composition category in 2022 or earlier may not compete in the Original Composition subcategory; they may compete in a different Composition subcategory.

Note that at this time we are unable to accommodate harpsichordists or organists.

GENERAL REQUIREMENTS





- We require that string and vocal performances be accompanied
 (unless the piece is composed for unaccompanied instrument/voice). Recorded accompaniments are permitted,
 but applicants should recognize the drawbacks for the expressive potential of their performances.
- All works must be memorized and performed from memory, including sonatas.
- For all video submissions:
 - Videos must be recorded live with no editing, reverb, or other audio filters or enhancements applied.
 - Videos must have been recorded on or after July 22, 2023 (i.e. within 6 months of the application deadline).
 - o For pianists, videos must be framed so that performer's hands and feet (pedaling) are visible.
 - o For string players, videos must be framed so both hands can be seen; the instrument's f-holes (not the scroll) should point toward the camera.
 - o For vocalists, videos must be framed so that the performer is visible from at least the waist up.
 - o The microphone used for recording should be no more than 8 feet from the performer.
 - The recording space should be as acoustically "dead" as possible.
 - o If the judges deem the recording quality too poor to evaluate properly, or see signs of editing or audio manipulation, the contestant will be disqualified with no recourse.

REQUIREMENTS BY CATEGORY

Piano Category:

Piano-1 Ages 8 to 10
Piano-2 Ages 11 to 13
Piano-3 Ages 14 to 17

Requirements:

One solo work each from the Baroque, Classical, Romantic, and Contemporary (composed post-1915) periods (four videos). For multi-movement works, the first movement is required; any number of additional movements may be performed within the same video.

Instrumental Category:

Instr-1 Ages 8 to 10
Instr-2 Ages 11 to 13
Instr-3 Ages 14 to 17

Requirements:

One solo work each from the Baroque, Classical, Romantic, and Contemporary (composed post-1915) periods (four videos). For multi-movement works, the first movement is required; any number of additional movements may be performed within the same video.

Vocal Category:

Vocal-1 Ages 16 to 18, all genders

Requirements:

Four works, which may be arias, art songs, or a combination (four videos).



Composition Category:

Comp-1 Ages 8 to 25

Requirements:

One submission from one of the following subcategories:

- 1) **Original Composition:** an original work for any instrument or combination of instruments, submitted in a commonly recognized music notation program such as Finale, Sibelius, or Dorico and saved as a PDF, and accompanied by a computer-generated playback or live audio recording.
- 2) **Composer/Performer**: One original composition to be performed by the composer on any orchestral instrument. Work must be submitted in a commonly recognized music notation program such as Finale, Sibelius, or Dorico and saved as a PDF. Original composition must be performed by and showcase the composer. Score must be accompanied by a live video recording of its performance showcasing the composer.
- 3) **Arranger/Performer:** One work of any length that is an interpretation, arrangement, or transcription of an existing work, written for any orchestral instrument or combination of orchestral instruments. This excludes "cover band" material, defined as a direct parody of another artist's work. Work must be submitted in a commonly recognized music notation program such as Finale, Sibelius, or Dorico and saved as a PDF. Score must be accompanied by a live video recording of its performance showcasing the composer.
 - For entries based on works in the public domain, only arrangements and transcriptions that have not been published or sold are eligible.
 - For entries based on copyrighted songs and pieces, the use of the "ArrangeMe" service
 (https://www.arrangeme.com) is encouraged. This web-based service, a division of Hal Leonard, includes
 1.8 million copyrighted songs and pieces that are pre-approved for arrangement or transcription.
 ArrangeMe takes care of permissions and royalties and handles sales. You must first self-publish your
 arrangement or transcription through ArrangeMe before submitting it to the competition.
 - For entries based on copyrighted songs and pieces not available through the ArrangeMe service, permission to arrange and distribute copyrighted works will be the responsibility of the entrant.

Permissions must be obtained before submission to the competition. Arrangements and transcriptions that have already been published or sold are ineligible.

Note: all Composition subcategories will be judged together, with none automatically given preference. Applicants should choose the subcategory that best showcases their abilities.

APPLICATION & SUBMISSION INSTRUCTIONS

Pacific Musical Society & Foundation utilizes a fully electronic application process. By **11:59 PM** on **Monday, January 22, 2024** complete all below items, following the instructions on **www.pacificmusical.com**:

- 1. Complete and submit the online application form.
- 2. Participation in the competition requires an application fee of \$100.00. Submit your non-refundable fee of \$100.00 when applying at www.pacificmusical.com.
- 3. Submit videos and scores via the link on **www.pacificmusical.com**. For performances, each work or movement must be a complete and memorized performance with no editing, and recorded in the last 6 months before the application deadline.
